1. Executive Summary

The Multipurpose Awareness Society, Hyderabad, proposes a project to ensure access to safe and clean drinking water in schools across the Yadadri Bhuvanagiri district. This initiative aims to address the critical need for clean drinking water, improving the health, attendance, and overall well-being of students in underserved areas. The project will involve the installation of water purification systems, regular maintenance, and awareness campaigns for students and staff on water safety and hygiene.

2. Objectives

1. Provide access to safe drinking water for over 10,000 students in Yadadri Bhuvanagiri district.

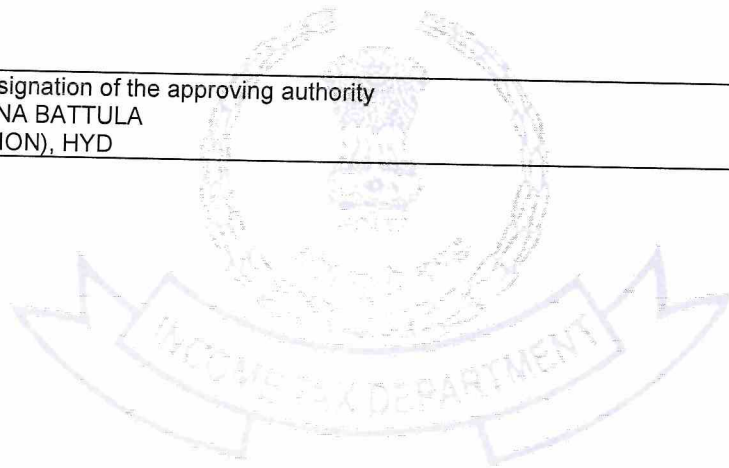

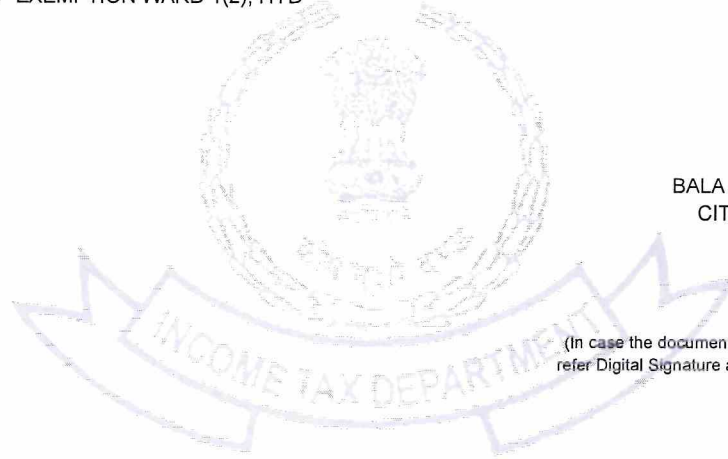

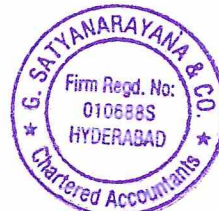
